What an EXTRAORDINARY year!

Starting with a moving New Year's Eve celebration commemorating the 150th anniversary of the signing of the Emancipation Proclamation, the National Archives Museum ended 2012 and rang in 2013 by welcoming more than 9,000 visitors who stood in line for a rare chance

to view the original document. This historic celebration – and the year that followed – demonstrated the best of the public-private relationship between the National Archives and Records Administration and the Foundation for the National Archives.

The opening of the new myArchives Store in late 2012 afforded grand space to better display the variety of products available, and the unveiling of the new Visitor Orientation Plaza in 2013 transformed the notion of a visit to the National Archives Museum from the moment you walk through the Constitution Avenue entrance. An open and graphically interesting lobby now gives the visitor a direct sight line into the new David M. Rubenstein Gallery and our latest permanent exhibit—"Records of Rights"—with its Magna Carta centerpiece.

Our wonderful Lawrence F. O'Brien Gallery served as the showcase for two important exhibits, one celebrating the records of our country and one celebrating the talents of our conservation staff. "Searching for the Seventies: The DOCUMERICA Photography Project" featured Environmental Protection Agency images of life in America during the early '70s. "Discovery and Recovery: Preserving Iraqi Jewish Heritage" documented the work of the National Archives' preservation staff to rescue and restore some 2,700 books and tens of thousands of Jewish historical documents found by American soldiers in the water-filled basement of Saddam Hussein's intelligence headquarters in Baghdad.

One more highlight of the year: presenting the Records of Achievement Award to filmmaker Steven Spielberg! Spielberg's career of retelling history through his films was meaningfully demonstrated this year with the release of *Lincoln* and his use of the records of the National Archives to get the story right. It is not often that a member of our staff, in this case, Kate Mollan, gets singled out in the credits of a major motion picture!

Can it get any better? You bet! The partnership between the Foundation for the National Archives and the National Archives gets stronger every year. And your support of the Foundation makes it possible for us to educate, entertain, and enlighten through our exhibits and public programs. Thank you for your generosity.

DAVID M. RUBENSTEIN GALLERY AND "RECORDS OF



The Foundation was proud to work with its partners at the National Archives Museum to significantly expand the museum's permanent exhibition space in 2013 with the opening of the new David M. Rubenstein Gallery and its "Records of Rights" exhibition at the National Archives Building in Washington, DC.

The project, which also included the opening of a new Visitor Orientation Plaza at the entrance to the museum, as well as the expansion of the myArchives Store, was made possible in part by a \$13.5 million gift to the Foundation from businessman and philanthropist David M. Rubenstein.

Mr. Rubenstein, a Baltimore native who is co-founder and co-CEO of The Carlyle Group, is a generous supporter of the Foundation and a champion of



the Archives' mission. He has loaned the National Archives Museum a Stone copperplate engraving of the Declaration of Independence, which is on display in the museum's "Public Vaults" exhibition, and his rare copy of the 1297 Magna Carta, now featured in "Records of Rights."

Magna Carta, the first English charter to directly challenge the monarch's authority, served as a precedent for the concept of freedom under law envisioned by the Founding Fathers, and set in motion the process of defining individual rights and civil liberties for all Americans.

The new exhibit, which opened in December, uses original documents, photographs, facsimiles, and videos from the Archives' collection to explore how Americans have worked to realize their rights in our democracy and how they continue to debate issues such as citizenship, free speech, voting rights, and equal opportunity. The exhibit showcases the drive for civil rights for African Americans, women, and immigrants, and includes a 17foot-long touch-screen interactive table where visitors can explore more than 300 additional records from the Archives collection, react to them, and share them with other visitors.

RIGHTS" EXHIBIT OPEN!

A complementary website, recordsofrights.org, allows the public to access the database from their home computers and experience the exhibition beyond the gallery walls.

In addition to supporting the creation of the gallery and "Records of Rights" exhibit, the Foundation joined the Archives' efforts to invite the public to become "citizen curators" through an online vote to help choose an original document to be featured in the gallery. The winning record was the 1868 joint resolution proposing the 14th Amendment to the states, which established the principle of "equal protection of the laws" and granted citizenship to "all persons born or naturalized in the United States." Foundation Board Vice President Cokie Roberts joined Deputy Archivist of the United States Debra Wall in unveiling the document during the Archives' first "Tweet Up," inviting participants to spread the word about the exhibit on social media.

ORIENTATION PLAZA

The new Orientation Plaza leading to the Rubenstein Gallery now serves as a gathering place for museum visitors, who can begin their visit in the gallery, then continue to the exhibitions on the second floor-including the Rotunda, the "Public Vaults," and the Lawrence F. O'Brien Gallery-as well as to the Boeing Learning Center and the William G. McGowan Theater. The ceiling of the Orientation Plaza includes a trompe l'oeil painting of the Archives Rotunda, giving the illusion of looking directly up into the room that holds the original Declaration of Independence, the U.S. Constitution, and the Bill of Rights. The Orientation Plaza also features a short film on eight video screens that tells the story of the National Archives' mission, collection, locations, and activities.

SEARCHING FOR THE SEVENTIES: THE DOCUMERICA PHOTOGRAPHY PROJECT

March 8–September 8 Lawrence F. O'Brien Gallery

The National Archives Museum took a new look at the 1970s through the lens of the federal DOCUMERICA photography project created by the **Environmental Protection Agency.** Drawing on the National Archives' extensive photographic holdings, the exhibit proved that the '70s produced not only leisure suits, streaking, and disco, but also profound changes in our politics, society, environment, and economy. Photographers working on the project captured the era's trends, fashions, problems, and achievements, creating a fascinating portrait of America from 1972 through 1977.

DISCOVERING THE CIVIL WAR

Taking a fresh look at the Civil War 150 years later, "Discovering the Civil War" featured more than 400 letters, diaries, photographs, maps, patents, amendments, and proclamations from the National Archives collection. The exhibit, which debuted In the Lawrence F. O'Brien Gallery in Washington before traveling the country, took visitors beyond battlefields and troop movements to explore the experiences of ordinary people during the war.

DISCOVERY AND RECOVERY: PRESERVING IRAQI JEWISH HERITAGE

In the spring of 2003, just days after the invasion of Baghdad, 16 American soldiers assigned to search for nuclear, biological, and chemical weapons entered Saddam Hussein's intelligence building. In the basement, under four feet of water, they found thousands of books and documents relating to the Jewish community of Irag - materials that had come from synagogues and Jewish organizations in Baghdad. "Discovery and Recovery" featured the dramatic recovery of these records in Irag and documented the National Archives' ongoing work in support of U.S. Government efforts to preserve them for future generations. The records were made available online at *ija.archives.gov* through the assistance of the U.S. Department of State, the National Endowment for the Humanities, and the Center for Jewish History.

RECORDS OF ACHIEVEMENT AWARD AND GALA



The Foundation named director Steven Spielberg the recipient of its 2013 Records of Achievement Award in recognition of his film legacy, which has brought to life defining moments of our nation's history.

The Records of Achievement Award is a tribute to an individual whose work has fostered a broader national awareness of the history and identity of the United States through the use of original records, including those preserved and protected for future generations by the National Archives.

Mr. Spielberg, a three-time Academy Award[®] winner, was recognized for his contributions as director of such historical films as *Lincoln*, *Saving Private Ryan*, *Amistad*, and Schindler's List. He also was honored for his work in creating what has become the USC Shoah Foundation Institute for Visual History and Education, which is dedicated to making audio-visual interviews with survivors and witnesses of the Holocaust and other genocides into a compelling voice for education and action.

Mr. Spielberg received the award at the Foundation's annual Gala at the National Archives Building in Washington, DC, on November 19– the 150th anniversary of President Lincoln's Gettysburg Address. Documentary filmmaker and Foundation Vice President Ken Burns, a past recipient of the award, chaired the private event.

Guests enjoy dinner in the Rotunda Galleries.

Foundation Chair A'Lelia Bundles, Executive Director Patrick M. Madden, and Archivist of the United States David S. Ferriero presented the award during a formal ceremony in the National Archives' William G. McGowan Theater. The black-tie event was followed by a dinner in the Rotunda Galleries, near the original Declaration of Independence, U.S. Constitution, and Bill of Rights.

Leading up to the Gala, the National Archives and the Foundation, in association with DreamWorks, hosted a public Steven Spielberg Film Festival November 15-18. The free film screenings of Saving Private Ryan, E.T. the Extra-Terrestrial, Amistad, and Lincoln, took place in the Archives' William G. McGowan Theater.

Despite a government closure and building construction, the myArchives Store continued to expand its reach, launching a new e-store and earning a "Best for History Buffs" recommendation from *Washingtonian* magazine.

The highlight of the year was the Foundation's launch of *myarchivesstore.org* on April 1. In nine months, the e-store generated significant online business, with an average sale of \$78.70 per order. Best-selling items throughout the year were reproductions of historical documents and the Foundationpublished *Genealogy Tool Kit.*

The store supported 58 book events in collaboration with the Archives' public programming team. A special "Evening with Congressman John Lewis" garnered the top-selling book event, generating sales of 182 copies of the limited-edition *Emancipation Proclamation* book, published by the Foundation in collaboration with Applewood Books. Over the course of the year, the store sold 2,479 copies of this book.

COMMUNICATIONS AND MARKETING

archivesfoundation.org website launched in October

The Foundation proudly launched a new website in October at *archivesfoundation.org.* The new site and accompanying social media efforts increase the Foundation's ability to raise funds in support of the National Archives and to market and promote the National Archives Museum's exhibits and programs.

Continuing its public outreach through print and online advertising, media events, direct mail promotions, publications, and online outreach, the Foundation supported exhibits in the Lawrence F. O'Brien Gallery and the new David M. Rubenstein Gallery, as well as programs in the William G. McGowan Theater.

LOOKING AHEAD





We take a moment in this report to look back and celebrate the successes of 2013. While we catch our breath, 2014 is upon us and

promises even more excitement as we work with our Archives partners to promote the National Archives Museum in Washington, DC, and exhibits and educational programming nationwide.

In early 2014, the Foundation will join Archivist David Ferriero in hosting the first-ever sleepover in the National Archives Rotunda, inviting families from around the country to unroll their sleeping bags and spend the night next to our most treasured records, the Declaration of Independence and the Constitution.

The History Channel's Brad Meltzer and fellow children's book author Cokie Roberts - a vice president on the Foundation's Board of Directors-will talk to visitors about their favorite historical characters and stories as families embark on treasure hunts through the "Public Vaults," practice writing with quill pens, try on historical costumes, and interact with impressionists portraying Abraham Lincoln, Amelia Earhart, and Phillis Wheatley. Our young guests will be entertained by a fife and drum corps and will enjoy a movie in the William G. McGowan Theater before turning in for the night, and Archivist David S. Ferriero and Meltzer will even flip pancakes for them in the morning!

In March, we and our Archives partners will launch "Making Their Mark: Stories Through Signatures." This year-long exhibition in the O'Brien Gallery promises to shed new light on the power of signatures contained in so many records of the National Archives and its Presidential libraries—not only those on paper and parchment, but those autographed on basketballs and soccer jerseys, as well as the "signature styles" of famous Americans, including Presidents Lyndon B. Johnson, Franklin D. Roosevelt, and Dwight D. Eisenhower and First Ladies Jacqueline Kennedy and Michelle Obama.

This spring and summer, leading up to the 60th anniversary of the famed Newport Jazz Festival, we will work with our partners to create a series of free programs and concerts featuring National Archives records related to the history of jazz music in America and exploring how this uniquely American art form was exported around the world.

The Foundation will continue its work in promoting the landmark "Records of Rights" exhibition in the new Rubenstein Gallery and its accompanying public programs, as well as through the exhibit's companion website recordsofrights.org throughout the year.
